All chairpeople should base their lives and recovery on Narcotics Anonymous and have a good working knowledge of the Twelve Steps and Twelve Traditions. Also, some experience on Convention Committee helpful.

Intent: Continuity of personal and service recovery.

2. Program Committee consist of Chairperson and a representative from each area. Persons do not have to be sent by the Area. If Area is not represented, fill in voted by Convention Committee.  Anyone can make a motion at convention meeting, but it must be seconded by a chairperson. Only chairs and executive committee have votes.

<u>Intent</u>: To develop consistency among committee and encourage participation throughout the Fellowship.

8. Security Committee should be formed.

Intent: To assist our members to stay within our spiritual principles.

9. Confirmations be sent out by Registration Committee.

Intent: To avoid confusion.

 Monies from fundraising and registration to be given to treasurer at meeting following event or collection.

Intent: To be more accountable of funds.

11. When next committee is formed, nominate co-chairs for all sub-committees.
<u>Intent</u>: To have members with experience for the next year. Qualification to correspond with chairpeople.
