Openly and freely I talked with these people that I was seeing on a regular basis, and they were accepting me not for what I wasn't but for what I really was. QUESTIONS FOR YOUR GROUP

- 1. What is the basic purpose of the Group?
- 2. What more can the Group do to carry the message?
- 3. Considering the number of addicts in our community, are we reaching enough people?
- 4. What has the Group done lately to bring the NA message to the attention of clergymen, physicians, judges, and others who can be helpful in reaching those who need NA?
- 5. Is the Group attracting only a certain kind of addict, or are we getting a good cross section of our community?
- 6. Do new members stick with us, or does turnover seem excessive?
- 7. How effective is our sponsorship? How can it be improved?
- 8. Has everything practical been done to provide an attractive meeting place?
- 9. Has enough effort been made to explain to all members the need and value of service to the Group?
- 10. Is adequate opportunity given to all members to speak and participate in other Group activities?
- 11. Are Group officers picked with care and consideration on the basis that officership is a great responsibility and opportunity for Twelve Step work?
- 12. Does the Group carry its fair share of the job of helping Area?, Region?, World?, and meetings in institutions?
- 13. Do we give all members their fair chance of Keeping informed about the whole of NA-Recovery, Unity, and Service?

Reprinted From NA Way July, 1984 In service to NA, "...there is but one ultimate authority, a loving God as he may express Himself in our group conscience..."

What is this thing called group conscience? How does it develop? When can we be sure it has been expressed? Upon what does it depend? Our basic text warns us, "...We must be constantly on guard that our decisions are truly an expression of God's will. There is often a vast difference between group conscience and group opinion... Some of our most painful growing experiences have come as a result of decisions made in the name of group conscience."

It seems that the getting together of NA members to discuss and decide upon an issue does not insure that the result will be the conscience of that group or an expression of our Ultimate Authority. The limiting factors seem to be the accuracy and completeness of information provided, and quality of recovery, or spiritual base, of the members involved.

Group conscience is only a channel for the expression of our Ultimate Authority. The clarity of the channel is dependent upon each individual's ability to clear a channel to a personal Power greater than themselves. Active addiction, especially in the form of deceit, manipulation, and selfimportance among participants, clogs this channel, and limits the ability of a group's conscience to accurately express an Ultimate Authority. The more surrender, faith, honesty, openmindedness, and humility a group shares, the more recovery exhibited by a group, the more accurately that group's conscience may express our Ultimate Authority.

We must have accurate information, however, and it needs to be presented without bias. Also the group must have sufficient time for all voices to be heard, all experience shared and an atmosphere of service through recovery maintained.

Some may feel that this Ultimate
Authority is all-seeing and all-knowing;
that the power of a loving God has expressed
Himself through group conscience transcends
the nasty reality of any lack of information
or inaccurate information. This may be true.
However, in our honest attempts to serve
through participation in a group conscience, we each use all the logic, experience, and common sense we have. We trust
the personal integrity of our servents. We
expect to recieve accurate, complete, unbiased, timely information from which to
draw conclusions and make decisions in the
name of group conscience.

This makes us extremely vulnerable to manipulation by trusted servents who lack integrity and would control communication. Many very wrong decisions made in the name of group conscience have been a result of manipulation in form of incomplete, inaccurate or biased information. While encouraging the members responsible to change and grow, we should be highly critical of such actions.

Perhaps the most exciting aspect of participation in a group conscience comes when we try to solve a recurring problem. Our primary purpose, maybe even the very lives of addicts seeking recovery, hangs in the balance. The problem looms larger than life. We have sought an answer though group conscience before but failed to find a solution. Old and new ideas fly around the room. We become frustrated and maybe even angry. What do we do? Each member seeks a conscience contact with their personal Higher Power. Perhaps a gentle voice from the rear of the group suggests quietly 'we could follow this new path...* The idea seems so clearly inspired, the group and its conscience feel very relieved, a loving Ultimate Authority has been expressed.

Experiences On This Step ...

IN GOD'S TIME

The Tenth Step

Since I have begun to practice this step, I have taken on a new attitude of which I have never had. My life has taken on a much greater meaning since I have stopped fighting everyone and everything. At the end of my day before going to sleep, I look through the day for any pain such as selfishness, dishonesty, resentment, and fear. Bid I make any judgements on anyone? Was I fearful of any situations? I admit them to my higher power asking forgiveness. During the day when I am conscious of these problems, I ask my higher power to remove them. I know that by experiencing this step I have tried to become the best person I can be and have become God-conscious. There was no work involved in this step, nor was it hard. I tried not to analize it and tried to listen to the suggestions from my two sponsors. I was told that this was to be done on a daily basis, which I did not understand, and that it would continue for a lifetime. I have a better relationship with my higher-power only by experiencing the Twelve simple Steps.

After experiencing the first nine steps with the help of my two sponsors, I was totally willing, as I had been with the previous steps, to begin on Step Ten. I was given my sponsors' experience with this step, which was to take a personal inventory of their day at the end of the day and to go over any of the character defects or shortcomings that we had noticed during that day. As any addict at first, I thought that by experiencing Step 6 % 7 that they would have been removed already, but alas, I was mistaken. They were to be removed, as it was explained to me, in God's time, not mine. I had merely been WILLING to have them removed in the previous steps.

I was told that anything I noticed during the day, such as anger, greed, selfishness, fear, etc., I would simply state to God and then thank him for the day I had. I did not ask for these things to be removed, but simply pointed them out. In time, I noticed that I began to notice these defects or shortcomings as they were happening, and to my surprise, they began to appear less and less, through none of my own doing, as I had tried so many times in the past. I may now have the ability to notice these defects, but understand that they will be removed in God's time, not mine. Something I also noticed was that things that happened in the

day, which I normally would have judged as good or bad, I do not anymore. I know that if God is running my life, they can neither be good or bad, but exactly what they should be. I have no expectations on this or any other step, and I simply do the step the way it was explained to me. My life today is definitely beyond my wildest dreams and imaginations.

An Addict's Experience With The 10th Step

My recovery began when I got two sponsors and asked them to help me experience the 12 Steps of N.A. At that time I was four years clean. I had faithfully gone to meetings everyday, used sponsors (when I was desparate), been very involved in every level of Service work, and I was still an emotional wreck. These sponsor's said they would sponsor me if I let them. I was at a point where I would do anything, so I said I would let them.

From that point to this I've had no major problems in my life. My job situation immediatley improved, and has continually gotten better. I have a good relationship today. I was about \$6000.00 in debt and now my slate is clean. I'm comfortable with my family and they are with me. My life is comfortable, enjoyable, and fulfilling. I attribute all of this to the 12 Steps of N.A. and a loving and caring God who is working in my life. These sponsor's helped me to experience this by sharing their experience with me.

With their guidance I took the first nine steps. It wasn't difficult; in fact it was pretty easy. They shared with me how they took the Tenth Step daily. It was simply taking a few minutes at the end of the day to look over the day. All I had to look for was fear, self-centeredness, dishonesty, and resentment. Whenever these things were evident, I just had to admit them to God. It was suggested that I shouldn't try to change these things - just admit them to God. If any of these things persisted, then admit them to another person as well.

It was stressed to me that CONSISTENCY with this and 11th Step were essential for success. Every night without fail this step is taken. It works real well. Recovery is progressing steadily forward.
