Deletion of material from the approved version of the Basic Text "Narcotics Anonymous" first received information informally in Maryland. Letter typed up by co-chair of region and was distributed to GSR's (see attached letter). Contacted RSR. He brought letter concerning 4th and 9th Tradition from WSC (see attached proposal). Turned over to Guido.

Guido - Passed out letter from conference. Will send area vote by regional mail and letter sent to area advising of vote. We did not get 60 days. Must be done by June 30 because there will be August printing of Basic Text. Last year this region voted to have sentences left in. Now we will vote as groups. We got too short notice. We can send letter as an area about this.

Discussion by Andy Orlando regarding Traditions 4 and 9. Discussed mis-wording of 6th Step in Basic Text. Proposals request 30-day decision dated May 14, 1984. - received June 10, 1984. Traditions were written as guidelines and protection for groups not to settle service structure disputes. (Cathy Daly) - Ask Alt. RSR when will we receive full report of what happened WSC 1984? Who made decision to stop printing Basic Text? (answer by Guido - no motion to stop printing) Are members of WSO voting participants? If so, whose group conscious do they carry? (Answer by Guido - This year service office manager (Bob Stone) has vote - vote taken and given to head of WSO (Chuck Gates - Chairman of Board) Do they have a vote in this issue regarding Traditions 4 and 9? (Answer: Yes - 37 regions plus 21 voting participants, totaling 58 votes).

Suggestion to area by Cathy Daly that we form an ad hoc committee to address issue of the 4th and 9th Traditions from WSC.
