The following motions are TO GO BACK TO THE GROUPS FOR GROUP CONSCIENCE:

- M/S Is our Area willing to become part of a Regional Hotline?

 Intent: To better serve the still suffering addict.
- M/S That future fundraisers be directed by the Administrative Committee for needs of the Area, also for the purpose of financing free Fellowship events (example, the May Day Mini-Convention), and that the Committee find responsible members to conduct fundraisers.
- M/S That ASRs [Area Service Reps] not serve on RSO [Regional Service Office]
 Board.
 Intent: So there will be no conflict of interest.
- M/S That all [Regional] Sub-Committee chairs be a 2-year position, except Convention Committee.
- M/S That the Meeting List format* be changed to accommodate the rapidly growing Region.
- M/S To withdraw the motion from the January 19th Regional Meeting presented by the RSO Board to put all RSC accounts under the parent account of the RSO, Inc. excluding the convention committee.

 Intent: By having the RSC accounts under the parent account of the office is a direct affiliation with the state of Pennsylvania. Also it is a direct violation of our sixth tradition.

(*The format now proposed for the Meeting List would be a 16-page booklet the same size as the White Book. There would be room for approximately 350 meetings. Also listed would be the Steps and Traditions, where and when the Areas meet, and the Hotline numbers for the Areas as well as New Jersey.)

In the Greater Philadelphia Region, Narcotics Anonymous groups are springing up at a rate that is astonishing and a credit to our Fellowship and its principles.

This is what it is all about, one addict helping another. Our primary purpose is to carry the message; obviously the message has been carried in the Philadelphia area. NA membership has quadrupled in the past two years, and continues to grow on a daily basis. Many groups who before held twenty members have now grown to 100 or more.

We would like to formally announce the formation of the Riverfront Area of Philadelphia.

In our service guide it states: "When an area or region grows to a point where it cannot efficiently serve its members' needs, that area or region should divide." Efficiency is the key word here. From a survey we have taken in our Fellowship, the most optimum efficiency has been achieved in areas containing 20 to 40 groups per area.

We feel that 20 or so groups can more efficiently interact and achieve a true group conscience.

The geographical boundaries are as follows: From north to south, from our city limits south on Roosevelt Blvd., to Cheltenham Ave., east on Cheltenham Ave. to Frankford Ave., south on Frankford Ave. to Erie Area., west on Erie Ave. to Broad St., south on Broad St. to the river. Our eastern boundary is the Delaware River.

As of Monday, June 6th, we have had 6 groups conscienced to join our area. More groups are coming, and we cordially invite other interested groups to become a part of. The groups are as follows:

As long as the ties that bind us together are stronger than those that would tear us apart, all will be well. We must live and work together. We set aside our differences and work for the common good.

Narcotics Anonymous is a God given program. With faith in a power greater than ourselves, hard work, and unity, we will survive, grow beyond our wildest dreams, and continue to carry the message to the addict who still suffers.

Unity is a must in Narcotics Anonymous. To maintain this unity and cooperation, we are asking for your continuing cooperation in the ensuing months, until this area can achieve true autonomy.

On Saturday, June 18th, at 2 PM at John McCullough Hall, Torresdale and Robbins Ave., our next area service meeting will be held.
