We are in desperate need of helpline volunteer numbers. These are used if needed; this doesn't mean you're a committee member. Numbers needed from West Philly, North Philly, West Oak Lane, and Germantown.

Dear Fellowship,

This letter is with concern for needed participation in our Helpline. We believe as a Fellowship that we can only keep what we have by giving it away. This is a spiritual principle we live in our recovery.

As members of Narcotics Anonymous, we each have a responsibility to carry the message to the addict who still suffers. It is one of the way we fulfill our ninth, eleventh, and twelfth steps. The Helpline is a direct result of "the therapeutic value of one addict helping another."

To get involved you need six months clean time and a willingness to serve. What is involved is attending one Helpline meeting a month and manning the telephone with other addicts as a team.

If we come together as a Fellowship and serve, we can strengthen Narcotics Anonymous. By doing this, we can better carry the message to the addict who still suffers.

We meet every 2nd and 4th Saturday at 6:00 pm at 2205 Bridge St. We encourage all groups and GSRs to elect a rep to support our unity. We're sure there are members in each group that would like to get a service commitment. Remember, if we're not working together, then we're growing apart.

We would like to set this up where groups will play other groups.
