THERE WAS NO QUORUM. MEETING WAS HELD FOR INFORMATIONAL PURPOSES ONLY.

Meeting opened at 11:15 am with a moment of silence and the Serenity Prayer. Minutes were read from the May 3, 1993 meeting.

Office Manager's Report:

Office Manager's written report is attached to these minutes.

In addition, the Office Manager showed Board members gold-plate and tri-plate medallions which he would like to purchase for sale at the RSO. (This has been brought up before, but because of the lack of a quorum, the RSO Board has not been able to vote on this.) Suggested sale prices: Gold-plate medallion -- \$10 (areas), \$11 (groups and individuals); Tri-plate medallion -- \$15.50 (areas), \$16.50 (groups and individuals).

These new medallions are being sold by an outside vendor, not the WSO. This vendor has an agreement with the WSO to use our medallions, which are then dipped or plated and resold. The Office Manager has purchased and sold a few of these medallions at the request of individual NA members.

Finance Committee:

The Treasurer's Report was prepared and presented by the Office Manager. A copy of the written report is attached to these minutes.

There was a question about our paying only \$8,000.00 of the \$11,299.68 balance owed to the WSO. This is being done at the suggestion of the RSO Board Chairperson. The decision was based on the fact that our cash flow has been rather tight recently and that the WSO does not charge us interest on outstanding balances. Paying \$8,000 rather than \$11,000 will give us a little more of a cash "cushion" this month.

There was a general discussion about the RSO Board's inability to take care of business and vote in new Board members because of the continuing lack of a quorum.
