The office has been running smoothly for the past month. It has been a very busy month. The new book is still selling well. I've had several problems this month with the copier and the repairman has been here two times and we need some parts that had to be ordered he will return on Oct. 5th to put them in and get us up and running smoothly.

For the last two month I've been waiting for a letter from our insurance company to send to the Realtor to repair office and replace any damaged merchandise, after speaking with the agent on the 24th he assured me we would have it by the first week of October.

As instructed by you I contacted a vender about a the book covers he said he would not have a price until the beginning of October because of the possible change in prices to him. As you asked about the cost of and additional phone line it would cost \$75.00 to turn on the line and a possible additional charge of \$43.00 for the first half hour then \$16.00 per 15 minutes there after that the installer would be at our office, I figure no more than an hour, probably less (cost approx. \$150.00)

The prices for thee Tri-plated medallions has been adjusted. I was only able to come up with two bids for the new computer system so I'll continue and get the third by your next meeting. The typing of the RSO bi-laws onto disc is completed.
