#### IV. RECEPTION OF REPORTS

#### A.AREA REPORTS

#### 1.PHILADELPHIA AREA

All groups doing well and support is good. Donation to Region \$60.00. All Sub-Committees doing well. Helpline is in need of donation from Riverfront and Inner City for Helpline bill.

#### 2.BUCKS COUNTY AREA

Our average group support is good. Our Sub-committees are doing well. Our Policy Committee is in need of support. We have elected Scott D. to represent our Area on the R.S.O. Board. Support from our Area concerning the Agenda Report was fair. Our Area has a donation of \$22.06 to go to the Region.

#### 3.CLEAN ACRES AREA

Area recognized new Saturday night "Restore Us To Sanity Group" meeting at United Methodist Church on High and Bernard Streets in West Chester at 8:30pm (Topic Discussion). This brings our area total to (18) groups and (25) meetings. All groups are represented well with a group conscience vote at area meetings. Business meeting support is adequate yet many need support. The Tuesday Night Alternative Group is having an ANNIVERSARY DANCE on SAT. MAY 20th at BOWLING GREEN INSTITUTE.

Group donations: March-\$844.72 & April-\$414.97. We are gratefully making a \$700.00 donation to the Region. In June, Clean Acres will celebrate it's

first anniversary. An Ad-Hoc committee has been (continued)

formed to investigate the possibility of an activity to celebrate the event. General elections for area trusted servants will be held in May and beginning in June. Nominations are being taken back to the groups for a vote. TWGS workshop held March 11th & Policy workshop held April 8th were both a success. Area policy was submitted to all groups which was developed at the policy workshop. It contains conflicting policies that the groups will vote on to be the final decision. Clean Acres has set Area policy for our RSO Board member to be as qualified as an ASR. There were many concerns in our area over the whereabouts of the convention profits. Due to a clerical error in our minutes our area would like to postpone the vote concerning the creation of a Regional Co-Treasurer. We are in favor of the creation of a meeting list sub-committee. Eight (8) groups completed their ASC Agenda reports this year. This month Clean Acres area services bought (16) tickets for the support of the regional conference. H&I Up until the last April H & I meeting, this committee was weakening very rapidly. Heavy discussions at the ASC meetings and group awareness has . brought this committee back to good standards. Problems exist with non-N.A. messages being carried into H&I facilities. Learning day tentatively planned for July 15. P.I./HELPLINE: Helpline workshop held April 29th was sparsely attended. Most things running smoothly with the little support they receive. P.I. has mailed out packets to (39) public and private schools. Presentation given on March 15th at Octoara H.S. was brilliant. P.I. is waiting for group direction to fulfill new projects. LITERATURE: The levels of literature and money are well to date in this committee.

# B. R.S.R. & R.S.R. ALT. & H&I SUB-COMMITTEE REPORTS FROM WORLD SEERVICE CONFERENCE 1989

- 1.Report from the World Service Conference 1989
  An outline of the multi-paged report which had been provided for all ASR's was gone through by RSR.
  Certain areas were indicated to be of strong interest:
  a.Motions from the Conference Agenda Report.

  - h.Motion for simultatious translations
  - i.W.S.O. Report concerning regions.
  - j.German Serenity Prayer

- R.S.R. ALTERNATE REPORT
- 1. The conference meetings were attended by 59 out of 60 regions. Japan was not present.
- 2.We had representation at the Conference Literature, H&I and PI.
- 3.I would like to inform the Region of the importance of having good representation at this conference and at the Quarterly's. I learned a great deal and I am grateful that I had the opportunity to serve the Region. I would like to thank Al R. for guiding me through the conference and helping me to understand more of the conference. His experience at the WSC was valuable and I feel he did an excellent job of representing our Region at this conference.
- 4.My only concern I have is that we have no reps at the WSC PI Committee. Because we have no reps I feel that we are going to miss out on a lot that this committee has to offer.
- 5.I also feel that the Region should look into the cost of sending Reps RSR & Alt., H&I and PI. reps. to this conference and to the Quarterlys.
- 6.With the 12 Principles of Service being discussed and new projects that the sub-committees are working on. The rewards would be more beneficial than the cost.
- 7. Another thing I would like to touch base on is the WSO has asked if any of our members runs across a store selling NA material—such as Basic Texts—Coins—Tapes, etc., that you send them the information of the stores name and location. The reason is there are some companies producing these materials and using the NA name. The WSO will take care of this, it is not up to the individual. The WSO feels that if it continues they will ask the WSC if they can take legal action.

I would like to thank the Region for allowing me the privilege to serve and be a part of the WSC conference. It was very educational and rewarding for me. I would also like to thank Swanny's wife for having their baby which made it possible for me to go.

W.S.C. H & I COMMITTEE REPORT - 1989
To the Regional Service Committee of Philadelphia, I would like to thank everyone for attending the workshops on the H & I Handbook. It was passed by unanimous vote and so forth all the motions on the WSC H & I committee were passed.

Of at least equal importance to the Handbook was the Committees decision to change its focus and direction in future years. We intend to get out of the project business. Our focus and priorities will shift toward information and education; getting out to multi-regional and regional events to assist in informing members about H & I and to be able to inform WSC and the WSC H & I about issued, problems and successes related to doing H & I work. As a result of this

decision we resolved to:

- 1. Initiate no new projects if we didn't have to.
- 2.Use the 89-90 Year to finish those projects already begun.
- 3. Meet at only one quarterly in the 90-91 Conference Year and at only two of the coming year.
- 4.To realign our budget to allow more funds for participation at Regional events. We hope the Fellowship will support us in this change of direction.

The existing projects we hope to finish includes a booklet and an audio tape. The booklet "BEHIND THE WALLS", is directed toward addicts beginning and maintaining their recovery while incarcerated. We have no literature which addresses the special problems of this situation. The committee is in the process of preparing a finished draft of this piece.

The proposed audio tape is of a mock panel presentation. One side is of an H&I presentation in a correctional facility and the other in a treatment setting. We realize some members are being called on to provide H&I services having never even attended an H&I presentation or never experienced a panel presentation and we wish to be able to provide guidance for them.

Often an H&I committee provides a meeting or presentation one night a week in a facility. The residents decide they want a second meeting and start one on another night. It is not an H&I meeting. What is it? We implore the Fellowship and the Conference to deal with this issue. Another example is the sixty women in the Federal Correctional Institution at Alderson, West Virginia, who holds a weekly N.A. Meeting. There is no area structure in their vicinity, no place to go for outside support. This concerns still suffering addicts and recovering members of Narcotics Anonymous who are shut off from the Fellowship which is out of our hands, and shut out of the structure, which we ask you to address. We do not want to go back to anyone anywhere starting up anything they please and calling We do not want to encourage meetings started and run by treatment or correctional staff members. The issue is broader than the scope of H&I. We ask you to develope a solution so these addicts needs can be met without diluting our principles or risking our credibility.

The WSO H&I department is updating its files in an attempt to obtain correct mailing addreses for area and regional H&I Sub-committees. This will facilitate referrals for services to addicts and professionals in correctional or treatment settings. We will also be able to send the REACHING OUT to Sub-committees.
