There was a report from a member of the WSO Board of Directors on a meeting that was held recently in Albequerque N.M. concerning the last two chapters of the Guide to Service. These are the chapters concerning the National and International Service Structures. Apparently these chapters propose that our world services be managed by a one board system which is similar to A.A as opposed the three board system that we presently have.
