"A Narcotics Anonymous group is any group that meets regularly, at a specified place and time, for the purpose of recovery, provided that it follows the Twelve Steps and Traditions of Narcotics Anonymous. There are two basic types of meetings: Those open to the general public and For Addicts only. Meeting formats vary widely from group to group; some are participation meetings, some are speakers, some are question and answer, and some focus on special problems discussions.
