Motion to groups - PASSED

NEW BUSINESS:

Motions on floor to GSR's:

Motion 1 - (from a subcommittee) PASSED

Motion: Area issue a check in the amount of \$45.00 to Tacony United Methodist Church for the used of the building on Sept. 28th, 1996. This is to be funded from the \$45.00 in donations from Learning Day.

Intent: To pay the rent for the use of the building on Sept. 28, 1996

Motion 2 - (from a group) PASSED

Motion: Article IX, Section B Subsection 5:

'Rule out any motion out of order.'

Delete the word "out" to read as 'Rule any motion out of order'

Intent: Housekeeping motion, redundancy.

Motion 3 - (from a group) - PASSED

Motion: Article XII 'AD-HOC COMMITTEES'

Add the words, "Ad-hoc should serve for no longer than one year unless a 2/3 majority rules further.

Intent: There should not be a need & would only prolong the work that is slowed & may need a new perspective.

Motion 4 - (from a group) - FAILED

Motion: Article IX, Section B, Subsection 6;

'Protect the ASC from frivolous or unnecessary motions by refusing to recognize them.' Delete the whole sentence.

Intent: Housekeeping motion - redundancy, already stated in #5 previous.

Motions from a group - to go back to the groups - to be voted on

Motion: To define the statement in policy Article II, Section A: "Special Interest Groups." To include as Addendum I of RASC policy.

"Any group that does not adhere to the spiritual principles of Unity & Anonymity by having a name that focuses on the differences of "drugs used, race, religious beliefs, sex, sexual preference or financial condition, rather than the similarities of desire to stop using, addiction, wanting what we have to offer & that self-sufficiency is a lie.

Intent: We feel that the ideal state for our fellowship exists when an addict can come freely & open to an NA meeting whenever & wherever they choose and leave just as freely. (Tradition 3, Pg. 62, 5th Tradition)

Motion: Article VI, Section M; Delete the words "will" in the second sentence and add "may". To read 'Only group tallies for CAR may be done by phone'

Intent: To further enable ASR to hear groups to ASC meetings and not only by phone. Housekeeping clarifications.

Motion: Article VI, Section I; Add the words to read '...be withdrawn by the maker (before it is seconded)'.

Intent: This wording will enable the RASC body to secure a motion on the floor that may have ABSTENTION purpose or use in another setting. (motion is related to Robert's Rules of Order)

OPEN FORUM:

The ASR has not attended area for 2 consecutive months. There is a concern that there is no connection with region and we do not have an alternate ASR at this time. Edie (Clean Sheet Rep.) has minutes.

M/S/P - To have T.C. removed from the ASR position, due to noncompliance of policy. Article VIII, 'Removal From Office'. The secretary will notify him by letter as per Article VIII.

M/S/P - Send a proxy to the region as a nonvoting representative to gather information to bring back to the area until an ASR is elected.

Intent: So all information from region be accessible to the ASC.

Henry accepted this responsibility and must be accompanied with a note stating the above.

Donations were atrocious and the ASC needs money to survive. We need to take a look at what we can do for the area and subcommittees. More money will be greatly appreciated.

The Unity chair was questioned on how the profit made from functions will be handled and who is responsible to keep/rack of the moneys. Danny will discuss this in the Unity committee meeting. It was also suggested that the groups discuss what should be done with the moneys from the Unity Committee profits - hold separately - separate funds in ASC account.
