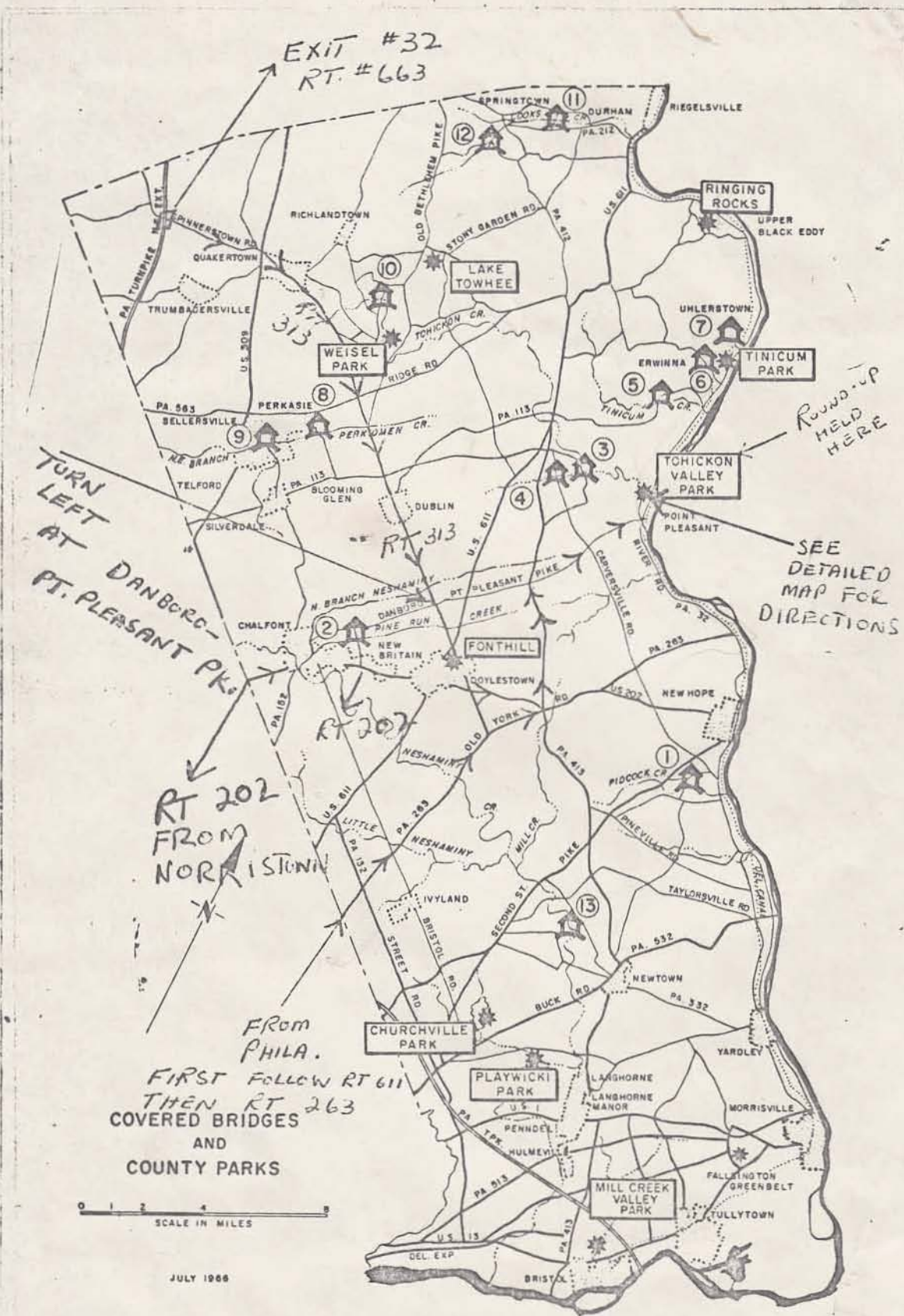

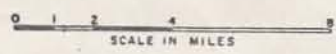

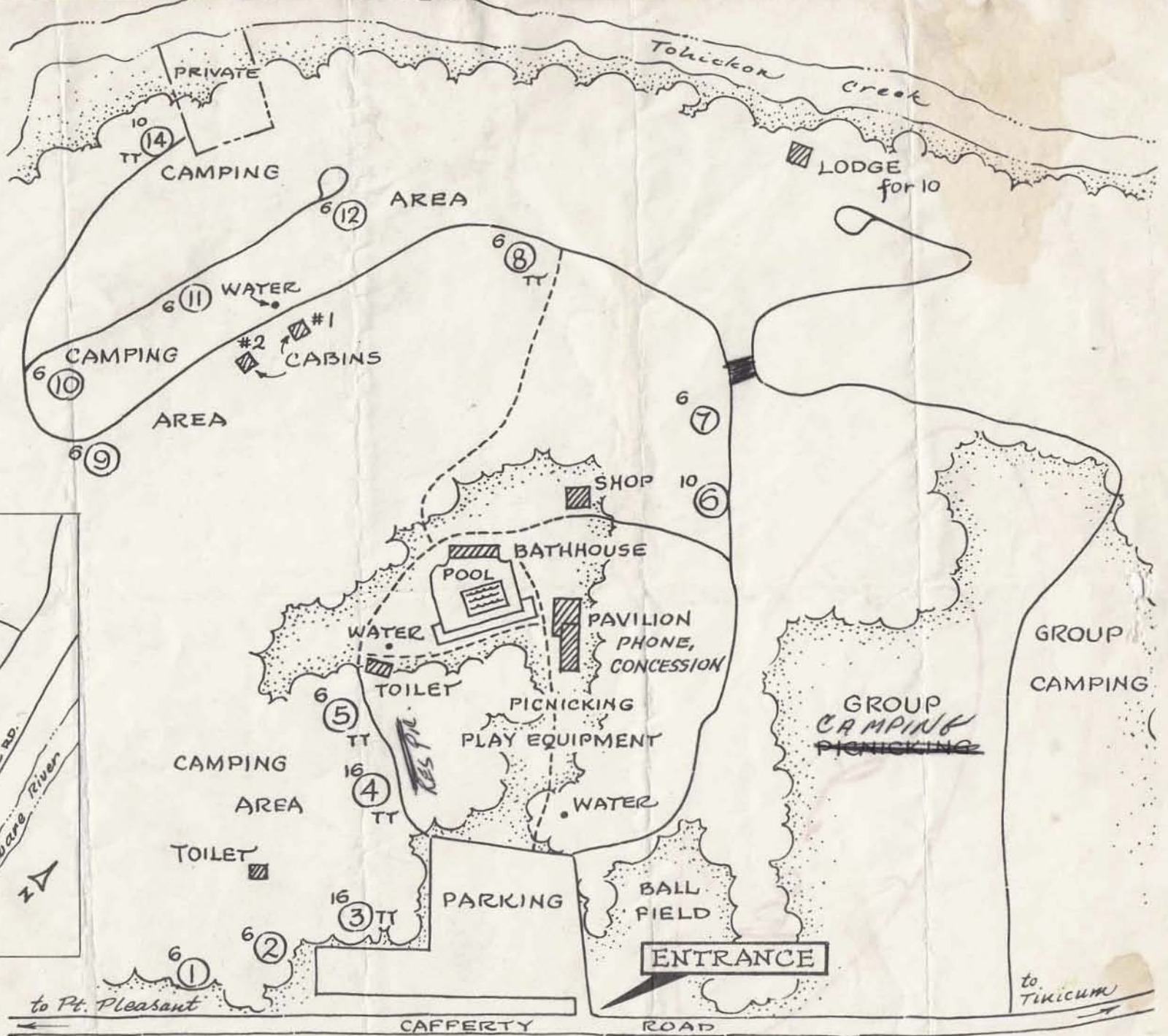

GENERAL INFORMATION (Applicable to All Rentals)

- * All applications must be made to the Bucks County Department of Parks and Recreation and will be treated on a first come first served basis.
- * Rental payable in advance - no application will be considered without full payment and submitted with complete information.
- * Make check and/or money order payable to the Bucks County Department of Parks and Recreation for full amount of rental, deposit and tax when applicable. Deposit will be returned by mail upon satisfactory use and condition of facilities.
- * Permits are revocable at any time and user must vacate premises upon request and/or notice by a Department employee/representative.
- * Park closes at dusk and opens at dawn unless special permit has been issued.
- * There shall be no tipping of Department employees/representatives under any circumstances. Gifts to a particular park will be received at the main office and officially acknowledged.
- * No reckless driving or speeding. Please park cars only in designated parking areas. Speed limit within the Bucks County Park System is 10 m. p. h. Keep vehicles on the road provided for same. No unlicensed motor vehicles shall be operated within the Park System unless a permit is issued. No motor vehicles shall be operated by a non-licensed driver.
- * Build fires only in designated area. Make sure all matches, cigarettes and pipe ashes are completely out before discarding them and do not smoke while walking through the woods. Fire allowed in grills and fire pits only. Firewood furnished as available.
- * No trenching or digging in camping area.
- * Damaging, defacing or removing any plant, sign, structure, equipment or other material is not allowed.
- * No motor propelled watercraft.
- * Pets allowed only on leash no longer than six (6) feet.
- * Alcoholic beverages and narcotics are prohibited.
- * Please use refuse cans.
- * Climbing trees is not allowed.
- * No hunting, shooting, trapping, carrying of firearms or bows and arrows.

- * Garbage and rubbish must be placed in cans provided.
- * Indecent language or immoral actions prohibited.
- * Bathing permitted only in swimming areas when lifeguards are on duty. Ladies must wear bathing caps. Special swimming rates are available to campers, cabin and lodge renters.
- * Horseback riding permitted only on designated trails.
- * Official permit issued must be available for inspection by a Department employee/representative at all times during park occupancy.
- * It is the duty and responsibility of each individual to report to the Department or Park Ranger any misconduct or violation of the aforementioned rules and regulations.
- * Violators may be prosecuted under law enforcement codes as set forth by the state, county or local municipality.

For emergency purposes, if a Park Ranger or Department representative is not on duty, please call the Bucks County Police Radio Room - Upper Bucks 795-2200 and Lower Bucks 945-3100 for assistance!

(5) Group Picnic Rules & Regulations

- * Permits are required for groups of twelve or more for administrative and supervisory reasons.
- * At present group picnickers of less than 50 are not assigned to a specific area.
- * In fairness to other park patrons, you are requested not to dominate more picnic tables than serve your group's needs.

(6) Reserved Group Picnic Rules & Regulations (See Fee Schedule)
