Dear Friends:

In response to my request to the World Service Office, I recently received a supply of Narcotics Anonymous booklets and other N.A. publications. We are grateful.

I am a recovering alcoholic, active in A.A., and the sponsor of two groups for recovering drug addicts in the Central Pennsylvania area.

The Lewisburg Group was organized on Jan. 24, 1972; the Williamsport Group on Sept. 22, 1972. We have nine recovering addicts who regularly attend meetings of both groups. Five have been clean for more than a year.

Since we organized, we have called the groups "Drug Abusers Anonymous." Since receipt of your literature, both groups have adopted new by-laws, and both groups decided to be known from now on as Marcotics Anonymous groups.

The new by-laws include a provision calling for monthly contributions to the World Service Office. The minimum contribution will be 25 per cent of the balance in the treasury on the last meeting date of each month.

We wish to be registered with the World Service Office and to be included in the next issue of the world directory.

We do intend to maintain communications with the World Service Office. We have adopted N. A.'s Sugrested Method of Leading a Meeting, and subscribe to the N.A. program as set forth in the booklet Narcotics Anonymous.

I did not expect to be writing to you atain so soon.

I wrote to you Feb. 19, enclosing a check for \$10.00 for 50 N.A. booklets. You may not even have received that order yet, with the mails so slow. However, we've already promised these 50 booklets --- to wordens at prisons in the area, parele and probation office personnel, and staff personnel at area hospitals. Alse, a rehabilitation center in the area wants becklets for addicts under treatment there. So we'll be needing more ϖ pies.

With this letter, I'm enclosing a check for \$20.00. Half the amount, \$10.00, is for 50 more booklets. The other \$10.00 is the Williamsport Group's first contribution to the W.S.O.

As I mentioned in my letter of Feb. 19, the Lewisburg, Pa., and Williamsport, Pa., croups recently adopted new by-laws which call for menthly contributions to the W.S.O.

The Lewisburg Group, unfortunately, can't send anything until next month. One of our members in that group split recently, after ripping off the treasury. We had accumulated some debts for a buffet supper we served on the group's first anniversary, so recent collections at meetings have been used for that.

Our real concern, of course, was not for the money that was stalen, but for the guy who stale it and returned to drugs. He is only 17. Someday, perhaps, he will return to the program, if he survives. This is real heartache, and I'm sure that all of you have experienced it.

I'm a writer --- a newspaperman --- and I've offered to help anybedy in the groups who wants to tell his or her story for inclusion in the forthcoming Big Book. We have one girl in particular whose story I'd like to see included in the book. She is only 16 now, and has been clean for 15 months. Her story is a real ni htmare, and anybody reading it would have to feel hope.

Den't forget to include the two groups on your mailing list, as I requested in my Feb. 19 letter. And drop those 100 co pies of the N.A. booklet in the mail as seen as you can. Send them to me at the address below. As I told you in my previous letter, I'm an A.A. member and sponsor of the groups.

This letter is to introduce you to Narcotics Anonymous. We are addictive people recovering from our addictions through a program of recovery borrowed from Alcoholics Anonymous. Our primary purpose is to stay clean from all drugs (including alcohol) and to help the suffering addict. Our membership consists of men and women for whom drugs have become a major problem. We meet regularly to share our experience, strength, and hope with each other in order to stay clean and help the new person find a drug free way of life.

We are not affiliated with any political, religious, or law enforcement agencies. We are under no surveillance at any time. The only requirement for membership is a desire to stop using drugs. As mentioned above our chief means of maintaining recovery and our primary group purpose is to help the suffering addict. It is in this respect that we are seeking your help.

Recently through our group contributions we have been able to obtain a telephone number with an answering service. This number is being made available to you with the hopes that we may in some way be able to help if you have a person who wants help with his or her drug problem. If you wish information concerning our program, call the number at the bottom of the letter and leave your name and phone number with the operator; members call in regularly to the service and answer any calls as soon as possible.

We are a fellowship of men and women for whom drugs had become a major problem. We meet regularly to help one another remain clean and sober from drugs. We are a non-profit organization, declining outside contributions, supporting ourselves by passing the hat to cover our minimal expenses. We are a spiritual program, yet we are not allied with any particular sect or religion. We encourage members to develop a belief in a Higher Power as they understand it. We are non-professional, relying solely on the bond of our common experience and our shared strength and hope. We have no leaders, though each group elects members to serve the group and handle any business the group may have.

Narcotics Anonymous has been active in the Greater Philadelphia area for the past seven (7) years. Our membership has been growing constantly, and we now have many active members in the area. One of our basic beliefs is that we continue to derive strength by sharing our message with the addict who still suffers.

Enclosed you will find literature entitled, "How It Works", which provides more detailed information on our program as a whole. A list of specific times and places of NA meetings is also enclosed.
