Pursuant to the Membership Corporation Law,

WE, the undersigned, all of full age, being desirous of associating ourselves together for the purposes as hereinafter more particularly described, pursuant to and in conformity with the Membership Corporation Law of the State of New York.

FIRST: That the corporate name by which said corporation hereby to be formed shall be known and distinguished is and shall be NARCOTICS ANONYMOUS, INC.

SECOND: That the particular objects for which said corporation is formed are as follows, viz.:

To voluntarily assist former narcotics users to abstain from the use of drugs and to ^{voluntarily} assist in the prevention of narcotic addiction among potential narcotics users by holding meetings and discussion groups under the supervision of competent lecturers.

To receive, collect, solicit, raise and administer funds for the above purpose.

THIRD: That the territory in which the operations of said corporation are to be principally conducted is in the State of New York.

FOURTH: That the principal office of said corporation shall be located in the City of New York, County of New York and State of New York.

FIFTH: That the number of Directors of said Corporation shall be not less than five (5) and not more than twenty-five (25).

SIXTH: That the names and places of residence of the persons to be the Directors of said corporation until its first annual meeting are:

Returned herewith is executed original proposed certificate of incorporation of the above. This certificate has been given careful consideration and I am of the opinion that, with purposes as stated therein, the approval of the State Board of Social Welfare is not required under the provisions of the statutes. If otherwise in proper form, it will undoubtedly be received for filing by the Secretary of State's office, provided the approval of a Justice of the Supreme Court is endorsed thereupon or annexed thereto. The statement of purposes is set forth in the certificate as follows:

"SECOND: That the particular objects for which said corporation is formed are as follows, viz.:

To voluntarily assist former narcotics users to abstain from the use of drugs and to assist in the prevention of narcotic addiction among potential narcotics users by holding meetings and discussion groups under the supervision of competent lecturers.

To receive, collect, solicit, raise and administer funds for the above purpose."

This letter is not to be construed as an approval of the State Board of Social Welfare, the State Department of Social Welfare, the Commissioner of Social Welfare, or any officer of the Board or of the Department, but as a statement that the approval of the State Board of Social Welfare is not required. When it is apparent on the face of a certificate that the approval of the Board is not required under the statutes, it has been the policy of the Board for the Department to return the certificate to the incorporators without either approval or disapproval.


