### Term of Officers -

Secretary and Chairman will be active one year and may be selected to serve a successive term.

### Duties of Chairman:

The duties of the chairman shall be to preside at all meetings of the governing committee; to appoint Committees wherever such are required. In the absence of the Chairman, or in the event of his inability to act, the committeemen next in seniority shall act as chairman in his stead.

### Duties of the Secretary:

The duties of the secretary shall be to keep a full and complete record of the business transactions of the governing meeting and of the Group to supervise the keeping of the books and accounts of the Group, and to discharge such other duties as may be prescribed by the governing Committee. The Secretary shall also receive and safely keep all funds of the Group, and deposit the same in such bank or banks as may be designated by said governing Committee, and such funds shall be paid out on the check of the Group signed by the Secretary and counter-signed by the

Chairman. The Secretary shall be an ex-officio member of the governing Committee.

Any Committee member who is in continual disagreement with the major voice in committee affairs to the point of departure from the traditional and accepted welfare of the Group may be asked to resign from such committee. A refusal to resign such member may be removed by a majority committee vote.
