## GROUP REGISTRATIONS: IS NA DYING?

Once upon a time in a faraway area, Joe and Josephine Addict went to the ASC meeting. Both were group service representatives and had to attend. They both picked up literature for their groups and found out when and where the local dance would be held. Among the paperwork they were given by the ASC chairperson were NA group registration forms.

Joe Addict took the literature, dance flyers, H&I sign-up sheets, and the NA group registration form to his group's meeting. He dumped everything on the literature table. A little while later, a newcomer asked an older member for his phone number. He grabbed the nearest piece of paper--the NA group registration form--off the literature table, wrote his phone number on it, and gave it to the newcomer. The newcomer took it home, copied the oldtimer's phone number into his phone book, and threw the form away.

Josephine Addict took all of her group's information home, remembering to take the literature and dance flyers to the next meeting. She put the NA group registration form in the trash, saying to herself, "What good does this do our group? It's just more busywork for me, the area, and the World Service Office. Besides, we're in the regional meeting directory."

Six months later, Joe and Josephine Addict decided to go on vacation together. They traveled all over, spending a few days at a seaside resort before moving on to a large city where Josephine's mom lived.

On their first full day in town, Joe looked at Josephine and said, "Hey, let's go to a meeting tonight."

Josephine said, "You're on! Let me call the phoneline." Josephine called directory assistance only to discover that the NA phoneline had been disconnected and there was no new number. "Now what do we do?" she asked.

"Call the World Service Office," said Joe.

The special worker who answered the phone at WSO first provided the phoneline number for the city Joe and Josephine were staying in.

"It's disconnected," Josephine said. "Can't you just look up a list of meetings and find out where they are?"

"Well," the special worker replied, "I'm real sorry, but we don't have any meeting information for that area."

"But you've got to!" exclaimed Josephine. "It's a huge city with hundreds of thousands of people. They've got to have NA meetings!"

"Well, we're sure they do, but no one has registered them, so we don't know where they are," the special worker sighed.

As she hung up, Josephine looked at Joe. He looked as stricken as she felt. Each was remembering a little piece of paper they hadn't filled out six months before. "What if a newcomer hit bottom tonight and wanted help?" Josephine whispered. "How would they find us?" She looked at Joe, as if for an answer. He didn't know either.

"The Message is Hope" is the theme for the Twenty-Fourth World Convention of Narcotics Anonymous, being held 1-4 September in Baltimore, Maryland. Flyers are included with this mailing. Several hotels have already sold out: the Sheraton, the Hyatt, and the Days Inn. The remaining hotel rooms are selling fast, so make your reservations now. Tickets for all four boat cruises are also selling quickly; they're still available as of this writing, but we expect them to be sold out before the convention.

WCNA-24 features the music of the O'Jays and The Temptations at Saturday night's concert. Rita Rudner, who has appeared on HBO, Cinemax, and the Tonight Show, among others, will entertain at Friday night's comedy show. Tickets for both of these performances are still available.

The Twenty-Fifth World Convention of Narcotics Anonymous will be held 14-17 September 1995 at EuroDisney just outside Paris, France. In order to give everyone sufficient time to plan for this event, flyers will be available at this year's world convention. We are looking into a discount package which will include airfare from several large North American cities and a four-night stay at EuroDisney. We'll keep you posted as this develops.

**INTELLECTUAL PROPERTY UPDATE**

The Fellowship Intellectual Property Trust, approved at the World Service Conference last year, describes how NA's trademarks and recovery literature are to be protected by the World Service Office. The trust makes a distinction between recovery literature and service materials. Recovery literature is defined as "any Narcotics Anonymous book, booklet, or pamphlet intended primarily for use or distribution within the context of an NA recovery meeting." Service material is defined as "those materials intended primarily for use within the context of an NA service board or committee." Use of recovery literature is protected under the trust, but service material isn't.

The FIPT allows for service handbooks such as the *Temporary Working Guide*, *A Guide to Public Information*, and the *H&I Handbook* to be adapted and reproduced locally to meet the needs of each NA community. The WSO board had discussed and decided that, at least until a new class of literature is designated in the trust, some service materials, however, should be given the same kind of protection prescribed for recovery literature in the FIPT. These are six booklets and pamphlets that are produced and distributed in much the same way as the recovery-oriented booklets and pamphlets you'll find on the literature tables at the meetings you attend:

- *PI and the NA Member*
- *NA: A Resource in Your Community*
- *The Group (pamphlet)*
- *H&I and the NA Member*
- *Twelve Concepts for NA Service*
- *The Group Booklet*

The WSO Board of Directors will discuss this issue further at its November 1994 meeting. The board invites members of the fellowship to share any ideas about this subject they would like the board to consider. All such input should be received at the office by 1 October.

## PRODUCT INFORMATION

### NA video approved by WSC

An NA video titled *Just for Today* was approved at WSC'94. It is a dramatization of one individual's life as she is touched and transformed by the NA program. The video follows the main character from the moment she first hears about NA to the time she takes a six-month key tag. The video conveys many aspects of the NA program, ranging from the concept of self-support to NA's distinction from other twelve-step programs. It can be used as an informational tool to communicate with those in the medical, drug treatment, educational, criminal justice, social service, and other helping professions.

The WSO Board of Directors is developing a marketing plan for the video to ensure that it is readily available to both professionals and local public information committees. As soon as it is available, we will notify you through the *Newslines* and other publications.

### New speaker tapes

The Tape Review Panel has approved twenty-four new speaker tapes. They will be available shortly from WSO. Look for more information about the availability of these tapes in future issues of the *Newslines*.

### New gold-plated medallions

WSO has new deluxe medallions available. Plated in 22-karat gold, they cost \$10.00 each. We stock eighteen-month and one to twenty-five year medallions. You can special order twenty-six to forty year medallions, allowing four to six weeks for delivery. These new medallions do not replace the gold/rhodium-plated deluxe medallions.

### New key tags

At this year's WSC, the WSO agreed to produce two new key tags. The first, commemorating eighteen months clean, is a gray tag stamped with silver foil. The other key tag honors members who are "clean and serene for

multiple years of recovery." It is black and stamped with gold foil. The new key tags sell for 28 cents each.
