Dear Kevin:

I would like to thank you for your time a few nights ago and apologize for the interruption. However, the information you provided me helped a great deal in regard to the above captioned matter.

Just after talking with you, I called Chuck Gates. I got his recorder and after identifying myself, I asked that he return my call. I have not heard from him. I did call John Orkner, the attorney for WSO, the next day. We had a good conversation and for the first time, he heard "the other side of the story."

After talking with Mr. Orkner, I wrote him a letter, a copy of which I enclose. I felt I had best define our position. I have called him once since then, but he was in court. I wanted to give him the opportunity to review my correspondence and to understand our position as to this controversy. I just called him again today and I was told he is still in court and will not be back in the office until Monday, March 21st.

At this time, I'm not sure of WSO's position, however, until I hear otherwise, I must assume they intend to proceed with printing the book. Considering the momentum of this controversy and its possible adverse effects on N.A. as a whole, I find this decision somewhat irrational and irresponcible. I have tried to maintain an open mind in this regard; but when one receives no response from the opposing side, its evident that the openmindedness is not shared.

Unless something is resolved in the very near future, I, myself, see no recourse available other than the courts. This has been our source of last resort, but I personally feel the evasiveness and the avoidance of this issue by the WSO will likely leave us with no alternative.

Dear John:

Pursuant to our conversation of this date, I am confirming the same and further confirming my representation of the Literature Sub-Committee of the World Service Conference of Narcotics Anonymous in relation to the above captioned matter.

As stated in said conversation, it is our opinion that the WSO do nothing further in regard to the printing of the captioned book for the following reasons:

- 1) WSO has failed to abide by the terms set out in the WSC in May, 1982. Namely, one the book be printed by September, 1982, and two, the book be printed verbatim.
- 2) Regional Service Representation of N.A. has notified WSO of the group conscience desire to do nothing further with the book until May, 1983.
- 3) Due to the confusion that is existing in this regard, another six weeks wait would be healthy for the organization as a whole.
- 4) Today the copyright application for the book was sent to the Register of Copyright Office for registration, a copy of which I enclose, and
- 5) The loss of money with the printer chosen by WSO (\$10,000 \$20,000?)
- 6) This book in question has had the "c" affixation on it since its original printing in November, 1981; therefore, giving the world notice of the same. I enclose a copy of the same.

With the above in mind, and also in an effort to cut out unnecessary legal expense, it would seem only reasonable that WSO wait until the WSC in May. However, I am aware that rational decisions are sometimes hard to come by from both sides of an issue. So, I will wait until I hear further from you before I pursue possible further remedies.

I appreciate your time and your concern in this regard and I am aware of the dilemma WSO is placed, however, I believe further action toward the printing of the book may create an even greater dilemma.
