WSO FILES LAWSUIT AGAINST DAVID MOORHEAD IN FEDERAL DISTRICT COURT - PHILADELPHIA

DEAR FELLOW N.A. MEMBERS,

I AM WRITING THIS NOTE TOWYOU TO MAKE YOU AWARE THAT THE WORLD SERVICE OFFICE, WITHOUT ASKING YOU OR WAITING FOR ANY GROUP CONSCIENCE, HAS COMMITTED FELLOWSHIR FUNDS TO A QUESTIONABLE END. THE PUBLICATION OF A CHEAP BASIC (EXT (\$1.10) HAS SEEMINGLY SENT STU TOOREDMAN OFF THE DEEP END. IT SEEMS THAT A SOLUTION TO THIS PROBLEM WOULD HAVE BEEN FOR WSO TO PRODUCE A BOOK ONE BASIC TEXT FOR \$1.10 THEMSELVES.

THE NECESSITY FOR EXPENSIVE, POINTLESS, PROTRACTED LEGAL ACTION AGAINST ME AS AN INDIVIDUAL IS NOT JUSTIFIABLE. ALL THE ACTION AGAINST ME AS AN INDIVIDUAL IS NOT JUSTIFIABLE. ALL THE COMMUNICATION FROM WSO INDICATED THAT THEY WANTED YOU, THE FELLOWSHIP, TO TELL THEM WHAT YOU WANT THROUGH A GROUP CONSCIENCE. THIS IS JUST ANOTHEL EXAMPLE OF OUR WORLD SERVICES IGNORING YOUR WILL IN MATTERS AT DIPECTLY AFFECT YOU AND THE FELLOWSHIP OF N.A. AS ALWHOLE.

I AM NOT WRITING THIS TO YOU TO TRY TO AVOID MY OWN PERSONAL RESPONSIBILITIES. I WOULD LIKE YOU TO SEND A LETTER TO THE WSO ASKING THEN IMMEDIATELY TO CEASE LEGAL ACTION UNTIL AFTER THE ASKING THEN IMMEDIATELY TO CEASE LEGAL ACTION UNTIL AFTER THE WORLD SERVICE CONFERENCE IN APRIL. I AM NOT SAYING THAT THEY WORLD NOT PURSUE SOME LEGAL REMEDY, ONLY THAT THERE SHOULD BE, A SHOULD NOT BE THE CLEAR AND ATE FROM THE FELLOWSHIP TO DO SO. IT SHOULD NOT BE THE CLEAR AND ATE FROM THE FELLOWSHIP TO DO SO. IT SHOULD NOT BE THE CEASE OF STU TOOREDWAN TO COMMITTUS IN THIS DIRECTION.

SECTION 8 IN THE CHARTES SECTION OF THE TEMPORARY WORKING SUIDE TO OUR SERVICE STRUCTURE CLEARLY GIVES US THE FE LOWSHIP APPROVED PROCEDURES FOR HAND UNG SITUATIONS SUCH AS THIS. THE TRUSTEES: AS GUARDIANS OF OUR CANDITIONS MAYE NOT EVEN ATTEMPTED TO FELLOW THESE PROCEDURES.

IN THE SUIT, WSO IS CLAIMING THAT THEY OWN THE TRADEMARKS AND COPYRIGHTS OUTRISHT. THIS IS GLEARLY NOT SO.

IF ONE WERE TO STUDY SECTION 2 OF THE WSO BYLAWS, IT IS OBVIOUS THAT THEY ARE ONLY A FIDUCIARY AND THAT HE MEMBERS OF NARCOTICS ANONYMOUS OWN THE COPYRIGHTS. SINCE WSO HAS FILED AGAINST ME, AS AN INDIVIDUAL, ASSERTING SOLE OWNERSHIP, LEGALLY AS A DEFENDANT, I AM DEFENDING MYSELF AS ONE OF THE DWNERS. IF WSO IS NOT SUCCESSFUL IN THEIR PURSUIT OF THIS CASE UNDER THESE WSO IS NOT SUCCESSFUL IN THEIR PURSUIT OF THE COPYRIGHTS AND PARTICULAR AND PECULIAR CIRCUMSTANCES, THAT WOULD MEAN THAT I. DAVID MOORHEAD, WILL BECOME THE OWNER OF THE COPYRIGHTS AND TRADEMARKS IN QUESTION, SINCE THERE ARE NO OTHER DEFENDANTS NAMED!

I DO NOT NEED TO TELL YOU THAT THIS SHOULD ALARM YOU AND THAT BY NO STRETCH OF THE IMPRILATION, OF I WANT TO OWN THESE ITEMS, I HAVE A GREAT DEGREE OF CONFIDENCE THAT I HAVE AVAILABLE TO ME ENOUGH INFORMATION, DOSUMENTATION AND LEGAL ASSISTANCE TO WIN THE CASE AS CURRENTLY PRESENTED BY THE WSO'S ATTORNEYS.
