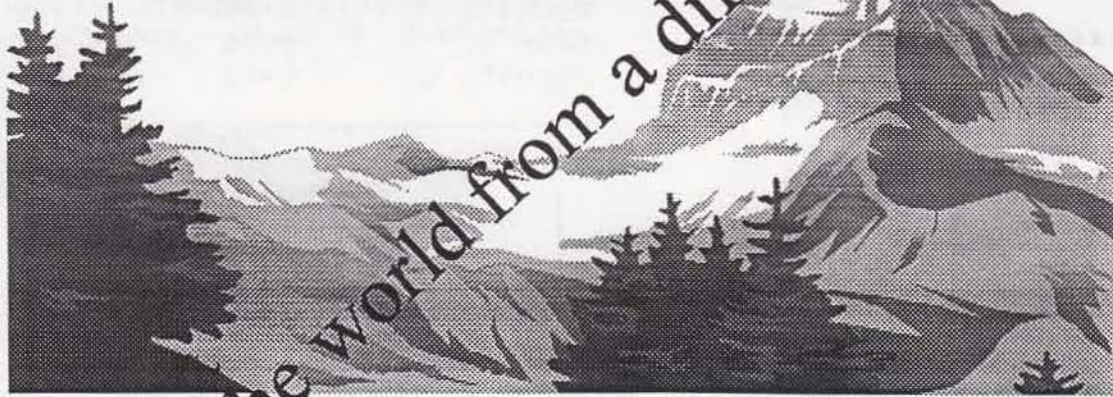

I blow up to such proportions that I cast a shadow over every field of labor.

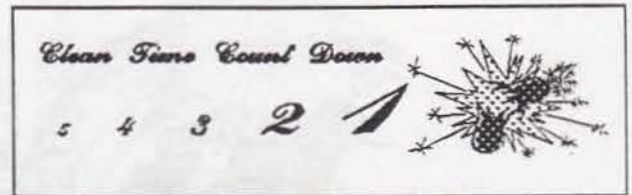
I am relentless, insidious, unpredictable; I am everywhere, in the home, on the street, in the factory, in the office, on the sea and in the air.

I bring sickness, poverty and death.

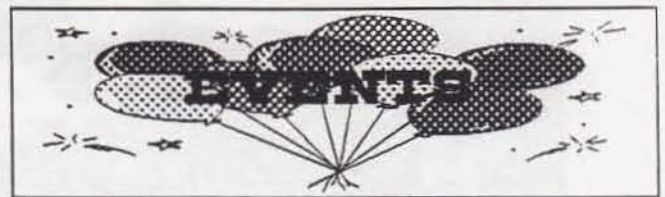
I give nothing and take all.
