Article 1 Membership

section one

To be eligible for membership a person must have 90 days of continuous sobriety and have approval of the executive board.

A. member may bring one guest with less than 90 days.

if the guest is asked to leave, the member must leave also for the day.

section two.

non members are cordially invited to all club meetings both social and business

section three

membership shall not be limited to any specific area.

section four voting members

any member who meets specifications in section one may vote in the election of directors.

Article 2

section one

voting members shall pay 3.00 dollars for first month

shall pay 5.00 dollars membership fee for each month after.

Article 3

organization the executive board shall consist of the following

A.

1. chair person
2. vice chair person
3. secretary

A. continue.

4. two treasurers

b. the club board will consist of three directors who will be elected by the member and the directors will appoint the other board members.

section 2

the duties of officers

chairperson - to coordinate all functions and activities of the club
the chair person shall preside at all business meetings of the club. The chairperson will present all new committees to the board for approval.

section 3

A chairperson shall have 2 years continuous abstinence and a member in good standings.

B. Vice -chairperson shall assume the duties of the chairperson in the chairperson absence and shall assist matters and assume such duties as may be assigned by the board.

A vice chairperson shall have 2 years continuous abstinence and be a member in good standings.

C. Secretary shall keep an accurate and permanent record of all business of custodian of all official records of the club and shall supply the minutes of the last business meeting by the next business meeting.

The secretary shall have one year continuous abstinence and be a member in good standings.

D. Treasurers - shall issue notice of dues payable and be responsible for the collection thereof, keeping an accurate record of dues finances, the director of the membership and submit a semi-annual report to the directors for audit.

Treasurer shall have 2 years of abstinence and be a member of directors for audit.

Treasurer shall have 2 years of abstinence and be a member in good standings.

Treasurer should have practical knowledge of accounting.
