As a beneficiary of this trust I request your office to investigate the activities of the WSO with regards to the accuracy of financial reports and data of WSO and its subsidiary corporations. Their compliance with their Bylaws, Federal and State laws governing operations of 501(c)(3) corporations seem to be in question and there are apparent discrepancies in the data obtained by us. An example of which is that in this years filing with your office there appears to be some \$700,000 + dollars unaccounted for.

DUE TO THE CURRENT CONFLICT OVER THE BASIC TEXT, AND OUR FEELING THAT WE ARE NOT HEARD OR NOT GIVEN ENOUGH TIME TO DISSEMINATE INFORMATION ABOUT ISSUES CONCERNING OUR BELOVED FELLOWSHIP, THIS IS OUR WRITTEN GROUP CONSCIENCE. WE DO NOT HAVE TIME TO WAIT FOR THE NEXT WSC. THE FOLLOWING OUTLINES SPECIFICS:

1. WE DO NOT WANT LEGAL REMEDIES TO BE SOUGHT AGAINST FELLOW MEMBERS OF THIS FELLOWSHIP. THIS IS AN INTERNAL MATTER, AND SHOULD BE SETTLED AS SUCH.
2. WE WANT FISCAL RESPONSIBILITY FROM WORLD SERVICE.
3. WE WANT THE UNITY OF OUR FELLOWSHIP RESTORED. WE DO NOT WANT TO BE CUT-OFF FROM THE EAST COAST OR HAVE THEM SINGLE-OUT AS RENEGADES.
4. WE WANT WORLD WORLD SERVICES TO REMEMBER THEY ARE ENTRUSTED TO HANDLE THEMSELVES IN A PRUDENT MANNER.
5. WE BELIEVE IN THE LITERAL TRANSLATION OF THE TRADITIONS. WE EXPECT YOU TO ADHERE TO THEM.

WE ARE SENDING THIS WRITTEN GROUP CONSCIENCE AROUND TO DIFFERENT GROUPS WITHIN NA. WE ARE NOT HAPPY ABOUT OUR WORLD. WE WANT SOLUTIONS TO BE REACHED WITHOUT NAME CALLINGS AND MUD SLINGING ETC. OUR LIVES DEPEND ON OUR UNITED STAND TO RESOLVE ISSUES THAT ARE THREATENING NA.
